DELINQUENT PROCEDURES

Monthly / Annual Payment Schedules

If no payment has been received by the 20th, a letter reminding the parent / guardian of their obligation will be sent.

If no payment has been received by the 10th of the following month, a phone call to the parent / guardian will be made to discuss the reason no payment has been made.

If no payment has been received by the 20th, an appointment / personal visit to the parent's / guardian's home will be made to discuss the problem.

If no payment has been received or an agreement has not been reached to pay the past due tuition, a registered letter will be sent to the parent / guardian informing them they will not be allowed to register their child(ren) for the next school year.

Quarterly / Semi-Annual Schedules

If no payment has been received by the first of the following month, a letter reminding the parent / guardian of their obligation will be sent.

If no payment has been received by the 20th, a phone call to the parent / guardian will be made to discuss the reason no payment has been made.

If no payment has been received by the first of the following month, an appointment / personal visit to the parents / guardians home will be made to discuss the problem.

If no payment has been received by the 20th, a registered letter will be sent to the parent / guardian informing them they will not be allowed to register their child(ren) for the next school year.
